Kentucky Farm Bureau Education Foundation Scholarship Program

Deadline: February 28, 2012

To be eligible:

- Have a minimum 3.5 Cumulative GPA...OR...a minimum 23 ACT Score.
- Be a child of a Kentucky Farm Bureau member and remain such, while the scholarship is in force.
- Finish high school within the year you apply for the scholarship NOTE:
 - There is only 1 Scholarship Application for all Scholarship Awards available.
 - To be eligible for one of the scholarships (Leadership *in Agriculture Scholarship*), student's parents must be actively engaged in production agriculture.
 - Children of Kentucky Farm Bureau Insurance Agency Managers, Agents, Agency Secretaries and CSR's are only eligible for the Kentucky Farm Bureau Insurance Agents Association Scholarship.
