Dear Parents,

Thank you for choosing Notre Dame Academy for your daughter. Your commitment to the value of single gender Catholic education is very much appreciated. We are grateful to have the opportunity to serve your family in this important ministry sponsored by the Sisters of Notre Dame. We understand that paying for a Catholic education can be a significant sacrifice and therefore we are diligent in our efforts to ensure that **a Notre Dame Academy education is a worthwhile investment** and one that is affordable to each of our families.

Below is tuition information for the 2024-2025 academic year. Notre Dame Academy continues to strive for excellence in our financial stewardship and remains sensitive to the financial challenges of our families.

NDA Tuition Rates for the 2024-2025 Academic Year

Per diocesan regulations, there are two rates of tuition: the Diocesan Rate for Catholic students registered in a parish in the Diocese of Covington; and the Non-Diocesan Rate for students who are not Catholic or who are Catholics from outside the Diocese of Covington.

DIOCESAN RATE For Catholic Students Registered in a Parish within the Diocese

Additional Fees:

Annual technology fee for grades 9 – 11 is \$300. Annual technology fee for grade 12 is \$75. Graduation fee for Seniors is \$125.

Athletic Participation Fee is \$275. Theatre Performer Fee is \$75 per show. Theatre Tech/Crew Fee is \$50 per show. Please know we are committed to providing an affordable education to all our families and that means working to meet the needs of each family based on their individual circumstances. Through the support of the Sisters of Notre Dame, the Diocese and many alumnae and friends of NDA, we have a tuition assistance fund for those who have financial need. We strongly encourage families who want their daughters to have the advantage of an NDA education, but are concerned about affordability, to apply for financial aid. Over 90% of the families who apply for financial aid through FACTS receive some form of assistance. This could include a grant, scholarship, a work-study job, or a combination of financial assistance methods. Every family that receives financial assistance from NDA is expected to have a Work Study Job.

The FACTS Management Company helps us manage our tuition payment program. If you are a current NDA parent already using FACTS, your account and payment plan information will remain the same. You will not need to re-register.

New parents who are not currently enrolled in FACTS will receive an email invitation from FACTS Management to enroll in a tuition payment plan in May. You cannot sign up until you receive the emailed invitation from FACTS. The invitation will contain your Unique Code for setup in the system and will contain detailed information about access to the FACTS system from our webpage. You will assign your own unique username and password and indicate your preferred tuition payment plan. You will be able to view your financial aid award package before you set up your payment plan.

New NDA families who currently have FACTS accounts through a grade school can keep their existing username and password and use the Unique Code to add NDA to their existing FACTS account.

Returning families will also receive a notification in May once financial aid awards and payment plans have been finalized.

Families who **pay tuition in full by June 30, 2024, will receive a credit of \$250**. You need to set up a FACTS account even if you pay in one lump sum. We use FACTS to manage our incidental billings so you will need an account regardless of your tuition payment choice. Incidental fees include athletic fees, theatre fees, and some other occasional fees such as field trips etc.
